Lost Boats

May

USS Lagarto (SS-371)

Lost on May 3, 1945 with the loss of 86 men near the Gulf of Siam. On her 2nd war patrol, she is believed to have been lost to a radar equipped minelayer. This minelayer was sunk by the USS Hawkbill (SS-366) 2 weeks later.





USS Scorpion (SSN-589)

USS Scorpion (SSN-589) was returning to Norfolk, VA. from a Mediterranean deployment. On May 22,1968 she reported her position to be about 50 miles south of the Azores. Scorpion was never heard from again. The exact cause of her loss has never been determined. 99 officers and men were lost.





USS Squalus (SS-192)

On May 23, 1939 USS Squalus suffered a catastrophic valve failure during a test dive off the Isle of Shoals. Partially flooded, the submarine sank to the bottom and came to rest keel down in 240 feet of water. Commander Charles Momsen and Navy divers on the USS Falcon (ASR-2) rescued 33 survivors use the diving bell he invented. 26 men drowned in the after



compartments. Later Squalus was raised and recommissioned as the USS Sailfish. In an ironic turn of fate, Sailfish sank the Japanese aircraft carrier carrying surviving crew members from Sculpin, which had located Squalus in 1939. Only one of survived after spending the rest of the war as slave laborers in Japan.

USS Stickleback (SS-415)

Lost on May 28, 1958 when it sank off Hawaii while under tow after collision with USS Silverstein (DE-534). The entire crew was taken off prior to sinking.

WASHINGTON – Lawmakers are resuming an effort that stalled in November to extend health benefits to about 90,000 sailors who served in Vietnam and were potentially exposed to Agent Orange.

Rep. Phil Roe, R-Tenn., chairman of the House Committee on Veterans' Affairs, introduced a reworked bill Friday that now includes a method to pay for extending Agent Orange benefits to Vietnam War veterans who were located on ships off the Vietnamese coast, known as "Blue Water" sailors.

Republicans and Democrats on the committee wrangled five months ago over the cost of extending the benefits to these sailors, though they all are seemingly supportive of the measure now.

"Today is a great day for Blue Water Navy veterans," Roe wrote in a prepared statement. "We owe it to the brave veterans who served in the Vietnam War to provide benefits for conditions they may have developed because of exposure to Agent Orange." Department of Veterans Affairs already presumes ground troops who served in Vietnam and others who served in the country's inland waterways were exposed to Agent Orange, a dioxinladen herbicide that's been found to cause respiratory cancers, Parkinson's disease, heart disease as well as other conditions.

Blue Water veterans have been denied the same benefits. The VA has argued there is not enough evidence to link Agent Orange to sailors' aboard aircraft carriers, destroyers, cruisers and other ships.

THIS IS THE REVISED CONSTITUTION AND BYLAWS TO BE VOTED ON IN THE 2018 USSVI NATIONAL. THEY ARE NOW POSTED ON THE NATIONAL WEBSITE (USSVI.ORG) AND THEN "DOCUMENTS" FOLLOWED BY "ORGANIZATION".

Explanation for Combining of Constitution & Bylaw Documents

The Constitution or the Bylaws, or both, are the documents that contain the basic rules and guidelines relating to an organization, as opposed to the parliamentary procedure that it follows. It is now the recommended practice by most government and taxing authorities that these documents be combined into a single instrument. Our Constitution and Bylaws Committee in cooperation with the Board of Directors have spent the last two years diligently working on this combining process. It was authored under the guide lines of: • Robert's Rules of Order, RONR (11th ed.) p 14 II.6-9 • The State of Connecticut • The IRS The intentions were to merge the documents to: • eliminate redundancy • wordiness that exist in the two current documents • update antiquated language and gender specific wording such as was found in the Auxiliary Article • incorporate all previous amendments and revisions • do so without changing the intent of the Articles. In maintaining the original intent of both documents, we eliminated the need to highlight wording changes. Shipmates, this combination has resulted in a simplified, smoother, and easier to understand document that we can use to govern USSVI.
